Collaborating with other organizations, including the U.S. Hispanic Chamber of Commerce, our strength comes from our commitment to the traditional notions of "familia". Moreover, our familia extends beyond our Hispanic brothers and sisters, as evidenced by our more than 45% non-Hispanic membership role.
